## **Jan. 15: Pacific Forum CSIS Board of Governors Meeting (Honolulu) \***

## **Jan. 27-29: US-China Strategic Dialogue (Beijing)**

Dialogue focused on US-China relations including regional security and global governance.

## **Feb. 4-5: US-ROK Strategic Dialogue (Maui)**

DTRA-sponsored dialogue focused on the US commitment to extended deterrence for South Korea and strategic relations in the Asia-Pacific region.

## **April 22-25: WSD-Handa Young Leaders Forum (Geneva)**

Young Leaders, with the support of WSD-Handa, will participate in the International Security Forum that brings together some 500 distinguished individuals who make and shape decisions relevant to international security, among them diplomats and other government officials, military, academics and representatives of international and non-governmental organizations from all over the world. The conference offers the international security community high-level cutting-edge analyses, briefs, and debates on the most relevant topics of international security.

## **Spring: CSCAP WMD Study Group (Asia)**

Study group examines nonproliferation and disarmament issues in the Asia-Pacific; held in conjunction with the ASEAN Regional Forum Inter-sessional Meeting on Nonproliferation and Disarmament (ARF ISM/NPD).

Field research in Asia, funded by the fellowship, will also be considered by the Director. Fellowships may begin as early as May 2013 and may be completed as late as January 2014.
