AMBASSADOR RICHARD L. ARMITAGE

Richard L. Armitage is the co-chairman of the Pacific Forum CSIS Board of Governors and President of Armitage International. He served as US Deputy Secretary of State from 2001 to 2005.



Mr. Armitage served as Assistant Secretary of Defense for International Security Policy from 1983-1989. From 1989 through 1992, Mr. Armitage filled key diplomatic positions as Presidential Special Negotiator for the Philippines Military Bases Agreement and Special Mediator for Water in the Middle East. President George H.W. Bush sent him as a Special Emissary to Jordan’s King Hussein during the 1991 Gulf War. From March 1992 until his departure from public service in May 1993, Mr. Armitage directed US assistance to the newly independent states (NIS) of the former Soviet Union. Prior to returning to government service in 2001, he was President of Armitage Associates L.C. from May 1993 until March 2001.

Mr. Armitage is a Naval Academy graduate (1967), and served in combat in Vietnam. He was awarded numerous US military decorations as well as decorations from the governments of Thailand, Republic of Korea, Bahrain, and Pakistan. Most recently, Her Majesty the Queen appointed Mr. Armitage an Honorary Companion of The New Zealand Order of Merit, in recognition of his services to New Zealand - US relations. Mr. Armitage is also an Honorary Companion of the Order of Australia, and was awarded the Knight of the British Empire. He is also a Knight Commander of the Order of St. Michael and St. George.
