It is our pleasure to welcome you to the United States—ASEAN Partnership Forum organized by Pacific Forum with support from the US Mission to ASEAN, and in cooperation with the Habibie Center, one of Southeast Asia's most esteemed research institutions. This gathering of top Southeast Asian and US foreign policy specialists, subject—matter experts, and next—generation scholars comes at an opportune time for US-ASEAN relations.

First, ASEAN is at the heart of regional integration efforts. With the launch of the ASEAN Economic Community (AEC) in 2015, the adoption of the ASEAN Master Plan on Connectivity 2025, and the ASEAN Community Vision 2025, the ASEAN member-states have demonstrated their commitment to being at the center of regional economic and security cooperation. As the US implements its whole -of-nation strategy in the Indo-Pacific, ASEAN centrality will continue to serve as the basic framework for strengthening partnerships in the region.

Second, ASEAN has become and remains the lead convener in the Indo-Pacific region. ASEAN hosts the East Asia Summit, the ASEAN Regional Forum (ARF), and the ASEAN Defense Ministers Meeting Plus (ADMM+). While these mechanisms have facilitated better understanding and provided opportunities for practical cooperation in the region, there is a growing sense of frustration with the persistence of tension between major powers, the pace of progress on building trust among ASEAN member states, and in ASEAN's ability to reach consensus on its strategic vision. Many in the region value US leadership and seek a clear strategy for enhancing US-ASEAN cooperation moving forward.

All of these factors point to important questions – What are innovative ways to strengthen US-ASEAN Strategic Partnership and deepen cooperation? How should the United States engage with the 10-nation bloc, amidst domestic political dynamics both in the West and in Southeast Asia, and to keep up with new twenty –first century realities? What policies should be pursued in Washington and in the capitals of Southeast Asia to address common challenges, successfully tap opportunities, and move US -ASEAN engagement forward?

Together, we will explore these questions and more, in a not-for-attribution setting designed to stimulate honest debate. Our hope is that this forum will result in innovative and actionable policy recommendations that can facilitate movement toward a more peaceful, stable, and prosperous Indo-Pacific region.

He holds a PhD in International Relations from the Fletcher School of Law and Diplomacy in the United States, and received both Ford Foundation and Fulbright scholarships. DSG Tuan has worked at various institutions, including the Institute for International Peace Research (PRIO) in Oslo and the Institute of Southeast Asian Studies (ISEAS) in Singapore.

COLLIN KOH SWEE LEAN, S. RAJARATNAM SCHOOL OF INTERNATIONAL STUDIES

Dr. Collin Koh is research fellow at the Maritime Security Programme, the Institute of Defense and Strategic Studies, S. Rajaratnam School of International Studies in Singapore. He has research interests on naval affairs in the Indo-Pacific, focusing on Southeast Asia. He has taught at Singapore Armed Forces professional military education and training courses. Currently, Collin is compiling a database of information related to the naval forces development, involving 18 selected countries in the Indo-Pacific, including incidences of the threat and use of force at sea.



JEFFREY ORDANIEL, PACIFIC FORUM

Dr. Jeffrey Ordaniel is the current holder of the endowed Rear Admiral Joe Vasey Fellowship at the Pacific Forum. His current work centers on the Forum's Security Cooperation Program, which aims to stimulate cooperative policies in the region through rigorous research, analyses and dialogues. Brad Glosserman is senior adviser of the Pacific Forum and visiting professor at Tama University, Tokyo. He is coeditor of *Comparative Connections*, the Pacific Forum's triannual journal and writes, along with Pacific Forum president Ralph Cossa, the regional review. He is also the coauthor, with Scott Synder, of *The Japan-South Korea Identity Clash*, a study of national identity in Japan and South Korea and its impact on U.S. alliances. Prof. John Lee is a senior fellow at the Hudson Institute (Washington DC) and the US Studies Centre (Sydney University). From 2016–2018, he was the National Security Adviser to the Australian Foreign Minister and the lead adviser for the government's Foreign Policy White Paper which was released in November 2018. He specializes in comparative politics of the Asia–Pacific, with a particular focus on issues of popular participation, governance, democratization, and contested institutions.

A 35-year veteran of journalism, he has reported from across Asia, and the United States, and his career has spanned *Bloomberg News*, *TIME Inc magazines* and the wire services *Agence France-Presse* and *United News of India*. A Singapore national, Ravi's interests span diplomacy, geopolitics and global business. An award-winning journalist, he is the author of *India Rising: Fresh Hope*, *New Fears*, a book on the decade leading up to the rise of Indian Prime Minister Narendra Modi.



MICHAEL MICHALAK, US-ASEAN BUSINESS COUNCIL

Amb. Michael W. Michalak joined the US-ASEAN Business Council in September 2015 as Senior Vice-President and Regional Managing Director. He oversees the Council's six offices in ASEAN from the Council's regional headquarters in Singapore.
